

ORDINANCE NO. 362

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, VACATING THAT PORTION OF A PUBLIC ALLEY WHICH EXTENDS IN A NORTHERLY AND SOUTHERLY DIRECTION THROUGH BLOCK THIRTY-THREE (33) OF THE OCEAN FRONT PROPERTY OF THE MIAMI BEACH IMPROVEMENT COMPANY, IN THE CITY OF MIAMI BEACH, FLORIDA.


WHEREAS, this body has been petitioned by the owners of all lots abutting upon that portion of a public alley which extends in a Northerly and Southerly direction through Block numbered Thirty-three (33) of the Ocean Front Property of the Miami Beach Improvement Company, in the City of Miami Beach, Florida, to vacate that portion of such alley, and it appearing that all of the owners who might be injuriously affected by such proposed vacation are in favor of same, and it further appearing that a certificate of the Miami Beach Abstract & Title Company, under date of October 3rd, 1934, discloses that there are no unsatisfied mortgages of record encumbering the above described property,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:


That all of the public alley which extends in a Northerly and Southerly direction through Block numbered Thirty-three (33) according to the Amended Plat of the Ocean Front Property of the Miami Beach Improvement Company, recorded in Plat Book No. 5 at Pages 7 and 8 of the Public Records of Dade County, Florida, be and the same is hereby vacated, discontinued and abandoned.

This ordinance shall take effect after the same shall have been duly passed, approved and posted, according to the law.






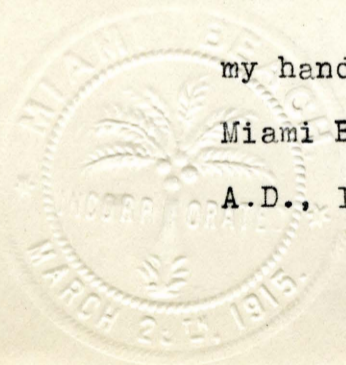
