ORDINANCE NO. 365

AN ORDINANCE OF THE CITY COUNCIL OF THE. CITY OF MIAMI BEACH, FLORIDA, AMENDING ORDINANCES NO. 257 AND NO. 317 THEREOF, AND PROVIDING FOR THE DIVISION OF SAID CITY INTO PRECINCTS OR ELECTION DISTRICTS AND POLLING PLACES THEREIN FOR GENERAL ELECTIONS OF THE CITY OF MIAMI BEACH, FLORIDA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1: That Section four (4) of Ordinance No. 257, as amended by Ordinance No. 317, be and the same is hereby amended to read as follows:

"Section 4: That for the purpose of holding and conducting such general elections the City of Miami Beach, Florida, is hereby divided into voting precincts or election districts with polling places therein as follows:

precinct No. 6: That part of the City of Miami Beach located north of Fifty-First Street, the polling place of which shall be the BOARDWALK FILLING STATION, 6925 Collins Avenue.

PRECINCT NO.30: That part of the City of Miami Beach South of Fifty-first Street and north of Lincoln Road, and that part of the Venetian Causeway which runs in an easterly and westerly direction across what is known as the Venetian Islands, the polling place of which shall be what is known as the LIBERTY AVENUE FIRE STATION located on Liberty Avenue of said City.

PRECINCT NO. 31: That part of the City of Miami Beach bounded on the south by Fifth Street and what is known as the County Causeway, on the East by Meridian Avenue, on the north by Lincoln Road and the Venetian Highway, and on the West by the City limits of said City, the polling place of which shall be the BAND STAND IN FLAMINGO PARK of said City.

PRECINCT NO. 32: That part of the City of Miami Beach bounded on the south by Fifth Street, on the west by Meridian Avenue, on the north by Lincoln Road and on the east by the Atlantic Ocean, the polling place of which shall be the CITY HALL of said City.

PRECINCT NO. 33: That part of the City of Miami Beach south of Fifth Street and what is known as the County Causeway, the polling place of which shall be in the MIAMI BEACH KENNELL CLUB ON COLLINS AVENUE SOUTH OF BISCAYNE STREET of said City. And the City Council shall appoint and designate, in accord with provisions of the City Charter, such inspectors and clerks of election for each such election district or precinct as by Resolution of the City Council/determined necessary, and thereupon the Mayor or acting Mayor shall issue his proclamation giving notice of such general election to be held in the City of Miami Beach, which proclamation shall contain a list of the officers to be voted for and the other questions to be voted upon; the places of voting; the time for opening and closing the polls and the names of the inspectors and clerks of election appointed as herein provided, and such notice or proclamation shall be published once a week for a period of four consecutive weeks next preceding such election in a newspaper published in the City of Miami Beach, Florida, and shall be posted for a period of thirty days in three conspicuous places in the City of Miami Beach, Florida, and the official ballot to be used at such general election shall be prepared by the City Council in the manner provided by the State law.

SECTION 2: That in order that public convenience be served this ordinance is hereby declared to be an emergency measure and adopted as an emergency ordinance by giving the same three readings at the same meeting, the second reading of which may be by title only.

SECTION 3: All ordinances and parts of ordinances in conflict herewith are hereby repealed.
