AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING ORDINANCE NO. 289 OF THE CITY OF MIAMI BEACH, FLORIDA, SO AS TO CHANGE THE USE REGULATIONS OF THE PROPERTY DESCRIBED HEREIN.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA

Section 1: That the use regulation of the following described property, to-wit:

> All of Blocks 113, 114 and 115, and Lots 3 to 9 inclusive, of Block 116, Ocean Beach Addition No. 4, as per Plat recorded in Plat Book 3 at Page 151 of the Public Records of Dade County, Florida,

be and the same is hereby amended so as to change said property from its present use regulations "BB" Business District, to what is known as "BAA" Business District, as said use regulations are described in Ordinance No. 289 as amended.

Section 2: All ordinances and parts of ordinances in conflict herewith be and they are hereby repealed.

Section 3: This ordinance shall take effect immediately after its passage, approval and posting in accordance with law.
