ORDINANCE NO. 407

AN ORDINANCE AMENDING ARTICLE 31 OF ORDINANCE NO. 233 OF THE CITY OF MIAMI BEACH, FLORIDA, REGULATING AND CONTROLING THE CONSTRUCTION, ERECTION AND INSTALLATION OF SIGNS WITHIN SAID CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

That Article 31 of Ordinance No. 233 of the City of Miami Beach, Florida, be and the same is hereby amended to read as follows:

SECTION 1: All signs attached to a building shall be fastened directly to the walls by well secured metal anchors, nor shall such wooden signs have electric lights or fixtures attached to them in any manner. Wooden supports or braces shall not be permitted.

SECTION 2: SIGNS EXTENDING OVER CITY OR PUBLIC PROPERTY:

No sign extending over City or public property shall extend over said City or public property more than a distance of thirty (30) inches, with a maximum height of six (6) feet, a maximum area of fifteen (15) square feet and sidewalk clearance of ten (10) feet. Supporting rods and fittings shall be not less than one-half (\frac{1}{2}) inch thick, lag and screw-lags shall be not less than one-half (\frac{1}{2}) inch in diameter and not less than three and one-half (\frac{1}{2}) inches long; no hanging arms to be less than one and one-quarter (1\frac{1}{4}) inch rods, and all plates for hanging arms attached to walls to be secured with no less than three (3) one-half inch expansion bolts and all bolts, cables, lags and shields to be of galvanized iron; signs on all buildings not constructed of concrete block or poured concrete shall have plates six (6) inches by six (6) inches by one-quarter (\frac{1}{4}) inch thick on inside of building with through one-half (\frac{1}{2}) inch bolts.

SECTION 3: SIGNS ON POLES: All signs hung on poles on private property shall be governed by the same rules and regulations and type of construction as in Section 2 hereof, and in addition all poles shall be not less than four (4) inches in diameter. Such poles shall be set in no less than four (4) feet of concrete and rock and the sign hung thereon shall not extend more than thirty (30) inches over City or public property. The maximum size of any sign hung on a pole shall be three (3) feet high and ten (10) feet long.

SECTION 4: SIGNS INSTALLED FLAT AGAINST BUILDING:

No sign installed flat against a building shall extend more than twelve (12) inches from said building and must be secured to building under rules and regulations as set forth in Section 2 hereof.

SECTION 5: ROOF SIGNS:

No sky sign shall be supported, anchored, or braced to a wooden building or structure. The maximum size of roof or sky signs shall to 16 feet long and 8 feet high over all, except by special permit from the City Council, and shall be erected not less than six (6) feet above roof line and shall be placed away from parapet walls in front of sign no less than fifteen (15) feet. All angles shall be no less than two and one-half $(2\frac{1}{2})$ by two and one-half $(2\frac{1}{2})$ by one-quarter $(\frac{1}{4})$ inch steel for uprights and cross braces; All shoes shall be three (3) by two and one-half $(2\frac{1}{2})$ by one-quarter $(\frac{1}{4})$ inches and U-bolted under and across at least four (4) roof rafters using no less than two and one-half $(2\frac{1}{2})$ by two and one-half $(2\frac{1}{2})$ by one-quarter $(\frac{1}{4})$ inch angle through U-bolts and also using no less than three-quarter (3/4) inch

All roof signs shall be of fireproof construction and shall be so constructed as to withstand forty (40) pounds of wind pressure for every square foot of cverall dimensions of sign.

SECTION 6: No wood or other inflamable matter shall be used in the construction of any sign to be erected or installed within the fire zone of the City of Miami Beach.

SECTION 7: All signs now installed in violation of the provisions as hereinabove set forth may continue in their present location until August 1st, 1936, at which time they shall be taken down and cannot be rehung or re-installed without permission of the Building Department of said City in conformity with the provisions of this Ordinance.

SECTION 8: No sign shall be so constructed as to obstruct any door, window, or fire escape on any building.

SECTION 9: Any letter, word, model, sign, device, or any representation in the nature of an advertisement, announcement, or direction, supported or attached wholly or in part, over or above any wall, building or structure shall be deemed to be sky-sign. As herein specified, sky-signs shall be constructed entirely of metal, including the supports and braces for same.

SECTION 10: Before the erection of any sign shall have been commenced, a permit for the erection of any sign shall be accompanied by complete plans and the written consent of the owner or owners or the lessee or lessees of the property on which it is to be erected. This Section shall apply to all signs hereafter erected, whether placed upon new or existing buildings.

SECTION 11: This Ordinance is hereby declared to be an emergency measure on the ground of urgent public need for the preservation of peace, health, safety and property, and shall become effective from its passage and approval as such.

SECTION 12: All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.
