BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI
BEACH, FLORIDA:


Section 1: That Section 5 of Ordinance No. 289, as amended,
be and the same is hereby amended by adding
thereto immediately following Item "(5) Private
Clubs", the words "only upon approval and
permit by the City Council of the City of
Miami Beach".

Section 2: All ordinances or parts of ordinances in con-
flict herewith, be and the same are hereby re-
pealed.

Section 3: This ordinance shall take effect immediately
after its passage, approval and posting in
accord with law.




