AMENDING ORDINANCE NO. 289 BEING THE
ZONING ORDINANCE OF SAID CITY, SO AS
TO ADD TO SECTION 1, THE DEFINITION
OF NIGHT CLUBS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI
BEACH, FLORIDA:

Section 1: That Section 1 of Ordinance No. 289, as amended,
be and the same is hereby amended by adding
thereto after the definition of "Clubs, private",
the following item:


"Clubs, night". The term "night club" shall
pertain to and include restaurants, dining
rooms or other similar establishments where
floor show or other form of lawful enter-
tainment is provided for guests after 11:00
o'clock P. M.


Section 2: All ordinances or parts of ordinances in con-
flict herewith, be and the same are hereby
repealed.

Section 3: This ordinance shall take effect immediately
after its passage, approval and posting in
accord with law.


