BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

Section 1: That the use regulation of the following described property, to-wit:

> All of Blocks 119, 120 and 121 and Lots 1 to 5, inclusive, Block 122, Lots 1 to 6, inclusive, Block 123 and Lots 1 to 6, inclusive, Block 124, Lenox Manor Subdi-vision in the City of Miami Beach, Florida, as said Lenox Manor Subdivision is recorded in Plat Book 7 at Page 15 of the Public Records of Dade County, Florida,

be and the same is hereby amended so as to change said property from its present use regulation "RE" Multiple Family District to what is known as "RDD" Modified Single-Family District, as said use regulations are described in Ordinance No. 289, as amended.

All ordinances and parts of ordinances in conflict Section 2: herewith be and they are hereby repealed.
