

ORDINANCE NO. 382

AN ORDINANCE OF THE CITY COUNCIL
OF THE CITY OF MIAMI BEACH, FLORIDA,
AMENDING ORDINANCE NO. 289, BEING
THE ZONING ORDINANCE OF MIAMI BEACH,
FLORIDA, BY ADDING THERETO A SENTENCE
AFTER PARAGRAPH DESIGNATED "DISTRICT
NO. 17", UNDER AREA REGULATIONS, SEC-
TION 16 OF SAID ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH,
FLORIDA:

SECTION 1. That Ordinance No. 289 be amended by adding thereto
the following sentence after Paragraph designated
"District No. 17", under Area Regulations, Section 16
of said Ordinance:


"In the area lying between Collins Avenue and
Miami Beach Drive and between 24th and 26th
Streets, both Collins Avenue and Miami Beach
Drive shall be considered as front."

SECTION 2. All ordinances and parts of ordinances in conflict
herewith are hereby repealed.

SECTION 3. This ordinance shall take effect immediately after its
passage, approval and posting in accord with law.



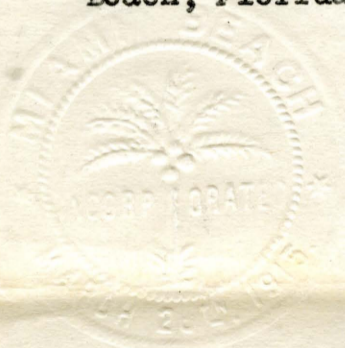
