ORDINANCE NO. 381

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING ORDINANCE NO. 289, BEING THE ZONING ORDINANCE OF MIAMI BEACH BY ADDING THERETO AFTER SECTION 5 OF SAID ORDINANCE, A SECTION DESIGNATED "SECTION 5-A", PROVIDING FOR AN ADDITIONAL USE' REGULATION DISTRICT DESIGNATED "BAAA-MODIFIED BUSINESS DISTRICT."

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

That Ordinance No. 289 be and the same is hereby SECTION 1. amended by adding thereto the following Section after Section 5.

> Section 5-A Use Regulations Modified Business District

In the "BAAA" Modified Business District, no building or land shall be used and no building shall be hereafter erected, constructed, reconstructed or structurally altered which is designed, arranged or intended to be used for any purpose, unless otherwise provided for in this ordinance, except for one or more of the following uses:

- Any use permitted in the "RE" Multiple-Family District. (1)
- Banks (2)
- Modiste, wearing apparel, furriers.
- (3)(4)Millinery shops
- (5)
- Offices, including Brokerage Houses. Interior decorating, costuming, draperies. 6
- 7) Antique shops.
- Jewelry stores.
- 9) Furniture stores.
- (10) Telephone exchanges.
- (11) Confectionery and ice cream stores.
- (12)(13)(14)Drug stores. Stationery stores.
- Shoe stores.
- Sporting goods stores. 15
- 16) Luggage shops.
- Sales and show rooms. (17)
- (18)Hotels or Apartment Houses with Fifty (50) or more guest rooms may contain, or erect in con-junction as accessory buildings, business estab-lishments of the "BAA" classification.

or other similar enterprises or businesses which are not more obnoxious or detrimental to the welfare of the particular community than the enterprises or businesses above enumerated, provided that this shall not be interpreted to include:

Bars or Bar-rooms, or restaurants, except in conjunction with an hotel or Apartment House of Fifty (50) or more guest rooms.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

This ordinance shall take effect immediately after its passage, approval and posting. SECTION 3.
