ORDINANCE NO. 378

AN ORDINANCE OF THE CITY OF MIAMI BEACH, FLORIDA, CHANGING THE NAME OF SHERIDAN AVENUE, BETWEEN 51ST STREET AND LA GORCE CANAL, TO LA GORCE DRIVE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI BEACH, FLORIDA:

SECTION 1. That that certain highway shown and designated as Sheridan Avenue on Plats of Beach View Subdivision and Beach View Addition, recorded in Plat Book 9 at Page 158 and Plat Book 16 at Page 10, of the Public Records of Dade County, Florida, and that portion of highway between the intersection of Pine Tree Drive and Sheridan Avenue and La Gorce Canal, shown and designated as Pine Tree Drive on a Plat entitled "Subdivision of Lot 1, Block 1, Beach View Addition", recorded in Book 34, at Page 62, Public Records of Dade County, Florida, be and the same is hereby changed in name and shall hereafter be known as LA GORCE DRIVE. In other words, the said LA GORCE DRIVE shall extend from 51st Street on the South to LaGorce Canal on the North.

SECTION 2. That all persons, firms or corporations owning property or residing upon the foregoing Street as renamed or designated herein are hereby required to observe the provisions of this ordinance in designating or numbering residences or posting signs or markers which may designate the foregoing Street.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
