- Paid 'NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of SW $\frac{1}{4}$, Sec.11-55-40, Tax \$1.81.' Check sent to Mr.W.U.Blackwell, Secy., in payment of this 11/12/'19;
- ✓ 'NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of SW $\frac{1}{4}$ Sec:14-55-40, Unknown, Tax \$1.81.' W $\frac{1}{2}$ of NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of SW $\frac{1}{4}$ owned by the P.G.L.Co. and they should pay tax.
- ✓ 'SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of SW $\frac{1}{4}$ Sec:14-55-40, Unknown, Tax \$1.81.' W $\frac{1}{2}$ of SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of SW $\frac{1}{4}$ owned by the P.G.L.Co. and they should pay tax.
