COPY OF RESOLUTION OFFERED BY DR. J. L. HOLMBERG
AT THE MEETING OF THE LANDOWNERS OF THE SOUTHERN DRAINAGE
DISTRICT, TUESDAY, JULY 8, 1930.

Be it resolved by the landowners of the Southern Drainage District that the Board of Supervisors of said Southern Drainage District be requested to take up with the Commissioners of the Everglades Drainage District, and the Board of Commissioners of Dade County, plans for necessary work to be done to relieve drainage in the back area by means of opening and widening Snapper Creek Canal to the Bay, ; also the construction of any other outlet canals or dykes which may work for the best drainage of the whole district and, if necessary, to construct locks to conserve the water during dry seasons. Copies of this Resolution to be sent to the Trustees of the Internal Improvement Board, Board of Commissioners of the Everglades Drainage District, Flood Control Board and Board of Commissioners of Dade County, Florida. Said motion was seconded by Mr. Killian and upon vote carried.

Be it resolved that the Board of Supervisors of the Southern Drainage District expend funds, if any are available, for immediate relief in cleaning out Snapper Creek Canal, if found advisable to do so.

Be it resolved by the Landowners of the Southern Drainage District that we the landowners, do hereby request Mr. Charles H. Crandon, County Commissioner from District No. 1, Dade County, Florida, and Mr. R. P. Barfield, Commissioner from District No. 4, to expend such bond monies for the roads provided by the Board of County Commissioners and as voted for in Bond Election in 1926 for roads on the following section lines, without further delay:

Beginning on the Section line in Section 5, Township 54 South, Range 39 East, where said line intersects the Tamiami Trail, and run South along the East section line of said Section 5 and East line of Sections 8, 17, 20 and 29 to the Southeast corner of said Section 29, in Township 54 South, Range 39 East, and thence East along the North line of Sections 33, 34, 35 and 36 of Township 54 South, Range 39 East, to where said line joins with Sunset Road in Section 31, Township 54 South, Range 40 East.
